Please read carefully and indicate your acceptance by initialing each paragraph:

1. _____ I understand that all animals assigned to me for fostering are the property of FMCA. Any such assignment is temporary and subject to the terms of this Agreement.
2. _____ I agree to provide my foster animal(s) with appropriate food, water and shelter. I understand that as a foster care provider, I am responsible for food, shelter, and litter expenses. FMCA will provide formula for bottle babies.
3. _____ I agree that I am responsible for ensuring that my foster animals receive prompt and regular veterinary care. I understand that FMCA is responsible for funding medical care for foster animals. I agree to get **approval** from the foster care coordinator or designated backup before taking the animal to the veterinarian. Approval will only be needed once to cover all routine medical care for foster animal. Exceptions to this will be made **ONLY** in the case of emergency.
4. _____ I understand that FMCA often has no prior knowledge of the foster animal's temperament or pre-existing medical conditions and, therefore, will not be liable for property damage or harm to persons or animals caused by this animal while in the foster home's care. FMCA will have animals tested and 1st shots before entering foster home if age and condition appropriate.
5. _____ I agree to provide care for my foster animals while I am away on vacation or business trips.
6. _____ I agree to keep and provide care for my foster animals until they are adopted.
7. _____ I agree I will not adopt out, give away, or release said animal(s) without specific permission from FMCA. All foster animals will be adopted following FMCA adoption policies, including an interview, adoption application and contract.

8. _____ I agree to actively participate in promoting my foster animal(s) by bringing them to adoption events (minimum of 2 times a month) or make arrangements for them to be brought to adoption events. I will make them available for photographs or provide photographs and biographical information for PetFinder.com. Most cats are expected to stay at the Luv A Pet Center or other satellite adoption locations on occasion.
9. _____ I agree to stay with my animals during adoption events and help promote them to suitable adopters. If I cannot stay with them, I agree to make alternative arrangements in advance. I also agree to bring their medical forms and documentation, if any, to adoption events.
10. _____ I agree to ensure that animals brought to adoption events are clean and healthy. (Claws are trimmed; no fleas, no ear mites, no runny eyes, etc.). If I am not comfortable with trimming animal's nails I will make arrangements with FMCA for an experienced person to do so.
11. _____ I agree to regularly trim my foster animal's nails so as to help them become familiar and comfortable with regular nail trimming. If I am not comfortable with trimming the animal's nails, I will make arrangements with FMCA for an experienced person to do so. I also agree to provide suitable scratching posts and materials to promote scratching on desired surfaces (not furniture) for cats.
12. _____ I agree to make at least one follow up call/inquiry to the families who adopt my foster animals within thirty (30) days.
13. _____ I agree to surrender my foster animals within 24 hours to FMCA, if requested to do so.
14. _____ I agree if I no longer wish to be a foster care provider, I will give FMCA adequate written notice to find alternative foster care for the animals in my care.
15. _____ I agree that this Agreement constitutes final notice of the requirements stated herein and no further notice is required for FMCA to institute legal action for violation of the terms of this Agreement.
